TO BE SIGNED ONLY BY PETITION FOR IMPEACHMENT OF CITY COUNCILMAN TOM BERG

Pursuant to Section 12-202 of the Charter of the City & County of Honolulu, as amended in the November 1992 general election, the following petition for impeachment of Councilman Tom Berg shall be submitted to the Supreme Court of the State of Hawaii:

WE, THE UNDERSIGNED, AS DULY REGISTERED VOTERS OF COUNCIL DISTRICT ONE IN THE CITY AND COUNTY OF HONOLULU, WITH FULL KNOWLEDGE OF THE CONTENT OF THIS PETITION, PETITION FOR THE REMOVAL OF DISTRICT ONE CITY COUNCILMAN TOM BERG FROM OFFICE BY IMPEACHMENT AS PROVIDED IN ARTICLE XII OF THE CITY CHARTER. WE SEEK THIS REMEDY BECAUSE WE BELIEVE COUNCILMAN BERG HAS COMMITTED MALFEASANCE AND MISFEASANCE BY KNOWINGLY AND/OR INADVERTENTLY VIOLATING FEDERAL LAWS, STATE LAWS, CITY ORDINANCES, ETHICS RULES AND THE COUNCIL'S CODE OF CONDUCT WHICH SERVE TO PROTECT THE PUBLIC FROM ELECTED OFFICIALS WHO SEEK TO EXPLOIT THEIR OFFICIAL GOVERNMENT RESOURCES FOR PERSONAL, POLITICAL, AND FINANCIAL GAIN, TO INCLUDE MISUSE OF TAXPAYER FUNDS AND MISUSE OF CITY WORKERS AS DE FACTO CAMPAIGN WORKERS AND FOR OTHER PRIVATE, NON-CITY PURPOSES. MOREOVER, WE BELIEVE THAT SUCH VIOLATIONS PLACE COUNCILMAN BERG IN DIRECT CONFLICT WITH THE CITY'S OATH OF OFFICE (§13-118), THE PURPOSES OF CITY POWERS (§2-102), THE POWERS, FUNCTIONS AND DUTIES OF HIS OFFICE (§5-103), THE REQUIRED ETHICAL CONDUCT (§11-101), AND THE PROHIBITION ON SPECIAL TREATMENT (§11-104).

UPON SUSTAINING THE CHARGES SET FORTH IN THIS PETITION, WE ASK THE STATE COURT(S) TO ORDER THE REMOVAL OF TOM BERG FROM THE CITY COUNCIL SHOULD HE NOT RESIGN.
